One of the major anti-Castro organizations in the United States is the Frente Revolucionario Democrático. Manuel Antonio Varona, more familiarly known as Tony Varona, is one of the leaders of this organization in Miami, Florida.

[redacted] We have received information to the effect that gambling elements in the United States have offered to contribute as high as two million dollars to finance the anti-Castro operations of Varona and the organization which he represents, apparently in the hope of getting in on the ground floor in what should be overthrown. (JFK)

[redacted] Edward E. Moss of Washington, D. C., reportedly is handling public relations matters for Varona and assisting him in raising funds. According to the information received one Julia Cellini is a mistress of Moss and operates a secretarial service here as a front for the activities of Moss. Our source reported that the father of Julia Cellini was a big numbers racketeer until a few years ago and two of her brothers allegedly were fronts for two of the largest gambling casinos in Havana during the Batista regime. The Cellini brothers are alleged to be in contact with Varona through Moss and it was through this channel that the offer of financial assistance was made.

Prior data available to us shows that three Cellini brothers were connected with gambling activities in Havana, Cuba, during the Batista regime. Goffredo R. Cellini and Edward G. Cellini were connected with the Casino Internacional, a gambling casino, as Afternoon Manager and Evening Manager, respectively. Dino Cellini was a floor man for the gambling casino at the Tropicana night club and was an overseer in the gambling casino at the Hotel Havana Riviera. Goffredo Cellini is known to have been associated with such hoodlums as Jack Lansky
