It is noted referenced CIA letter and Bureau radiogram referred to "TEOFILO BABUN FRANCO" as co-owner of Antillean Marine Shipping Corporation. However, during interview, TEOFILO BABUN SELMAN advised that he is owner-operator of the shipping company mentioned and that TEOFILO BABUN FRANCO is his nephew, who is not connected with this shipping business and not in the Miami area.
