EDUARDO GARCIA, on 7/13/64, had advised that he had thoroughly discussed this matter with ~~his CIA representative~~ (S) B but would be willing to discuss the matter with the NYO.

Arrangements were made to interview GARCIA on 7/14/64 but interviewing agent was unable to keep this appointment, and GARCIA did not want to discuss it with any other NYO representative. Another appointment was made to interview GARCIA on 7/15/64, but because of personal reasons, GARCIA was unable to keep this appointment. GARCIA, on 7/15/64, stated that business matters make it impossible for interview on 7/16/64, but a scheduled interview with GARCIA has been arranged for 1:00 PM on 7/17/64. Results of interview with GARCIA on 7/17/64 will be submitted in summary teletype and LHM.
