EDUARDO GARCIA MOLINA advised that he had fully discussed this plan with his CIA contact in a telephone call from Miami to Washington, D. C. in either late January or early February, 1964. GARCIA said he thought this would be a good idea to have foreigners carry out the plot, and it was for this reason that he informed CIA of the details. GARCIA said that when CIA told him that they were not interested in this plot and wanted no part of it, he lost interest in it and only paid casual attention to the whole plan as it evolved.
