ReBu airtel 7/9/64, advised that CIA, on 7/8/64, reported that the information in the 4/8/64 CIA memorandum came from two sources. CIA, however, did not have their identities available. CIA advised that it was instructing CIA, Miami, to furnish the Miami Office the identities of the sources involved, and to make the sources available to the Miami Office for interview.

On 7/10/64, [CIA OFFICER J] CIA, covert, Miami, advised that it would be necessary for him to confer with his headquarters prior to revealing the sources of information.

On 7/13/64, [ J ] stated he was still discussing the matter with his headquarters, and would notify the Miami Office when the sources were available.

It is noted that referenced Bu airtel refers specifically to the sources in the memorandum dated 4/8/64. In view of the conflicting information obtained through interview of TEOFILO BABUN SELMAN and his associates, ELISEO GOMEZ FERNANDEZ and OSCAR FERNANDEZ VEIGA and the information obtained through interview of JULIO LOBO at New York, it would be of interest to the Miami Office to have the sources of the information set out in the CIA memorandum of 6/10/64, available for interview, particularly with regard to the information appearing in Paragraphs 3, 6 and 8.

The Bureau is requested to advise whether the question of making these sources available for interview by the Miami Office was discussed with CIA.
