On 7-30-64 CIA furnished following information:

The sources of CIA's memorandum of 4-8-64 and CIA's letter of 6-10-64 are identical. The sources are [redacted]

[redacted] CIA believes your office has interviewed both of these individuals. In this regard CIA noted that both individuals are employed by a small firm in Miami whose officers and employees are aware of the plan to assassinate selected Cuban Government leaders. CIA believes that, if Bureau were to reinterview the two sources, it would suggest to them that the FBI's interest in reinterview resulted from information received by Bureau from CIA. Sources have expressed opinion to CIA that, should it become known that they were reporting this kind of information to CIA, they would be immediately fired from firm where they are presently employed. As a result of above, CIA has requested that we not reinterview these individuals. However, if Bureau feels reinterviews imperative, CIA requested the following conditions be applied:

- (1) FBI reinterview all people concerned and treat all the interviewees in a like manner.
- (2) Interviews be so conducted that information originally furnished from CIA's sources will not appear either to sources or to others interviewed as the basis for reinterviews.

CIA considers the above-mentioned sources as valuable [and feels that CIA must request the above conditions be placed on possible reinterviews in order to protect the confidential nature of the information as revealed by its two sources. In addition, CIA feels that, if the question was raised as to whether or not CIA furnished the information on the identity of the sources to the FBI, CIA would have to deny having furnished such information on the identity of the sources to the Bureau.] (S)

Bufile in this matter indicates [redacted] has been interviewed; however, there is no indication that [redacted] has been interviewed although it is possible this has already been done. (S)

Immediately submit your recommendations [relative to the interview of the above-mentioned CIA sources,] bearing in mind results of investigation already conducted. (S)

In addition, suairtel whether Byron Cameron who allegedly is involved in this matter has returned to Miami from Mexico and whether the interview with him has been conducted. Also advise Bureau of any additional leads outstanding and when it is contemplated these leads will be covered.

Following completion of above, submit recommendations as to whether additional investigation is warranted.

This matter must be given continuous and preferred attention.

NOTE:

We have been conducting investigation at request of Attorney General of alleged plans to assassinate Cuban Government leaders. Allegedly, U. S. hoodlum element and Cuban exiles are involved. We have furnished all pertinent information developed to date to the Attorney General and other interested agencies. Investigation to date has failed to disclose any connection between hoodlum element in U. S. and Cuban exiles.

Miami Office requested we determine CIA sources of information contained in CIA communications dated 4-8 and 6-10-64. We contacted C in this connection and information set forth above is the result. MAY 23 1964
