Subject appeared at our Seattle Office and identified herself as a Polish born Canadian citizen who had been a housekeeper for Lajno Reich in Montreal, Quebec. She claims that the day before the assassination of President Kennedy she overheard a radio conversation Reich was having with an unknown person in Cuba and that Reich was making arrangements to have Oswald assassinate President Kennedy.
