Re WFO airtel, 9/14/60, concerning info furnished by WF 279-S* relating to a request from a Mr. KEEVILLE of the Democratic National Committee to IGOR D. BUBNOV of the Soviet Embassy concerning photographs or films the Embassy may have depicting Senator JOHN F. KENNEDY with Premier KHRUSHCHEV or other Soviets. The same informant subsequently furnished info concerning a recontact between the above-mentioned individuals and the info in the enclosed memo reflects the substance of both contacts.

There are enclosed for the Bureau six copies of letterhead memo captioned "NIKITA SERGEYEVICH KHRUSHCHEV" and dated as above.

The enclosed letterhead memo is classified "Confidential" as it reflects investigative interest in a diplomatic representative of a foreign power and because info furnished by the informant could result in the identification of an informant of continuing value.
