Criminal Record for applicant and relatives.

Applicant advised on application that he had been arrested for a traffic violation in Melrose Pk., Ill., in 1949.

Lieutenant M. Giles, Melrose Park Police Department advised that no permanent record is made for minor traffic arrests and that his files reflect no arrest record for applicant.

## Military Status

Enlisted in United States Army on 10-31-42 as a private, he was honorably discharged on 12-19-45 as a Private First Class. His record is clear. Applicant advised on interview that he was a member of the inactive reserves. Captain James E. M. Hair, 6103 ASU and Instructor, Organized Reserve Corps., 1720 Mishawaka Ave., South Bend, Indiana, advised that he had no record of the applicant being a member of the inactive reserve at South Bend, but that it was quite possible that the applicant had not notified the Organized Reserve Corps of his move to South Bend, and that he might still be carried on the membership roll of his former residence district. Miss Elaine Scrugli, clerk Selective Service System, Local Board 107, Riversid, Illinois advised that applicant is presently classified 5-A, overage for induction.

States applicant dresses conservative has ordinary features, is neat, has friendly approach, is well-poised, has clear voice, is self-confident, has average tact, average enthusiasm, is forceful, cooperative, alert, mature, answers questions deliberately, above average intelligence, has no investigative experience, appears to be resourceful, and has the appearance of a young business executive or professional man and with training and experience the applicant is likely to develop into an average to above average employee. He further states applicant weighs 215 pounds but is not obese, giving a stocky, athletic appearance. He carried himself well and made a very good impression. He appeared to be mature, sure of himself, but not cocky. FPC Negative. Recommendation: Favorable
