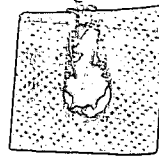
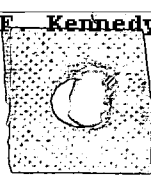

CG 6792-PC ADVISED GIANCANA DID NOT RETURN TO CHICAGO ON OCTOBER 13 LAST AS SCHEDULED. INFORMANT STATED APPARENTLY SOME UNEXPECTED DEVELOPMENT AROSE IN THAT TWO INDIVIDUALS FROM KANSAS CITY CAME TO GOLF COURSE ON TUESDAY LAST AND ADVISED JOHN CAMPANALE THAT GIANCANA HAD AN APPOINTMENT WITH THEM FOR THAT DATE. INFORMANT STATED CAMPANALE HEARD TO STATE THAT GIANCANA EXPECTED THAT DAY AND INASMUCH AS HE DID NOT APPEAR CAMPANALE COULD NOT STATE WHEN TO EXPECT HIM. TWO INDIVIDUALS TOLD TO GO TO ARMORY LOUNGE AND MAKE CONTACT WITH BUTCH BLASI WHO WOULD BE ONLY PERSON WHO WOULD BE IN POSITION TO ADVISE RE GIANCANA'S PLANS. INFORMANT CLAIMS THAT BASED ON CONVERSATION HEARD SATURDAY NIGHT LAST THAT HE FEELS GIANCANA WITH PHYLLIS MC GUIRE. u

NOTED SANDY SMITH, SUN TIMES REPORTER SERVED SUBPOENAS ON ANTHONY TISCI AND CHUCK ENGLISH IN CONNECTION WITH SUIT INSTITUTED BY ATTORNEY ANTHONY CHAMPAGNE AGAINST SUN TIME AND CHICAGO POLICE DEPARTMENT. BASED ON SUCCESS ATTAINED THROUGH PUBLICITY OF HOODLUM APPEARANCES TO GIVE DEPOSITIONS IN WILLIAM FISHMAN SUIT, NEWSPAPER FEELS THIS TACK CAN BE AGAIN USED SUCCESSFULLY. SUBPOENA ALSO AWAITING GIANCANA, STRONG POSSIBILITY EXISTS HE WILL REMAIN OUT OF AREA FOR UNDETERMINED PERIOD UNTIL OBSERVING MANNER IN WHICH DEPOSITIONS AND RESULTANT PUBLICITY HANDLED. u
