He also heard FRIEDLANDER also sent some money to JOSEPH INDELICATO (Miami file 92-404), another Miami Beach Shylock, but he was not told how much. These loans, he understands, were the result of his wife's long illness.

He also advised on 8/8/62, that SOL WAX, a "new-comer" on Miami Beach, opened up Gino's Restaurant at 1906 Collins Ave. and at present the rear rooms are being re-modeled in order to carry on some gambling and bookmaking activities. He further learned that WAX, who is connected with the "hoodlum element," purchased a four bedroom home at 5525 La Gorce Drive, Miami Beach.
