




WEEKLY SUMMARY

MM 819-C* advised on 9/4/62, that GEORGE HYMAN LEVINE, partner in the Harold Solomon Bail Bond Office, Miami Beach, made a deal with the Cadillac Hotel, Miami Beach to handle the window cleaning of that hotel, and was attempting to locate a window washing firm to contract for the work. DAVE YARAS told LEVINE he would obtain a window washing outfit for him. The same source related that on September 5, 1962, LEVINE told MAX COHEN, an associate of SALVATORE GRANELLO (Miami File 92-442), that he was notified by JOSEPH INDELICATO, (Miami File 92-404), that he was trespassing at the Cadillac Hotel and INDELICATO ordered LEVINE to meet with him at the office of E. DAVID ROSEN, Miami attorney, who represents INDELICATO. On 9/5/62, LEVINE, COHEN INDELICATO and ROSEN were observed in front of ROSEN's office.

JAMES W. CARIOTA, PCI, estranged husband of PATRICIA CARIOTA, advised on 9/4/62, that he learned ANTHONY RICCI (Miami File 92-112), moved from 7846 N. E. Bayshore Court, Miami, to apartment 3 at 11935 N. E. 19th Drive, North Miami. He said that on Wednesday night, 8/29/62, he caught RICCI in front of 11935 N. E. 19th Drive and physically beat up RICCI because RICCI broke up his home. According to CARIOTA, he told RICCI that if

he did not get out of Miami he would kill him. He further related that he also told RICCI he intends to beat him up everytime he sees him.

MM 509-C on 8/28/62, advised that JACK FRIEDLANDER, (Miami File 162-93), arrived in Miami on the date of 8/24/62 or 8/25/62, from Las Vegas, Nevada, where he had been working in a gambling casino at \$50.00 a day; that FRIEDLANDER was presently hanging around the Bayshore Golf Club, Miami Beach and that in about ten days to two weeks he was going to leave for the Bahama Islands to take over a good job in a gambling casino.

This source also advised he heard that a highly placed Miami Beach politician has a piece of JOE MORRISON's bookmaking and betting operation. He said it was rumored that BERNIE FRANK, a Miami Beach City Councilman, is the one who is in with MORRISON, (Miami File 92-101).

In addition this source related that GUIDO CASERTA, Operator of the AC Tile Co., Miami, is the fence for WILLIE DARA, (Miami File 87-8078), and that CASERTA frequents "The Apartment", a tavern and lounge in North Miami Beach, operated by DARA and JOE MORRISON.
