WEEKLY SUMMARY

MM 606-PCI on September 26, 1962 advised that HYMAN MARTIN (Miami File 92-218) and his associates are presently operating bolita in Broward County, Fla; that MARTIN continues to pay off ELI QUAIN, and that QUAIN makes payoffs to the Broward County authorities. He said he understood the payoff to Broward County authorities is over \$300.00 per week. This source also reported that he was told that MARTIN and his associates are suspicious of JAMES CHRISTIAN, a bolita operator, who is one of MARTIN's bolita operators, but could furnish no specific information as to why they are suspicious of CHRISTIAN.

MM 833-PCI advised on 10/5/62 that JOSEPH INDELICATO (Miami File 92-404) had a visitor on 10/4/62 who was overheard to say he had just returned from Jamaica. This source said there was some discussion had with this person concerning the numbers racket but the source was unable to furnish any details.

MM 509-C on 9/25/62 advised he was told that practically all the gamblers, bookmakers and racket individuals in the Miami area bet on LISTON in the recent LISTON-PATTERSON prizefight and that ANTHONY SALERNO (Miami File 92-406) bet \$16,000.00 to \$10,000.00 on LISTON; RUBY LAZARUS, close associate of SALERNO, bet \$8,000.00 to \$5,000.00 on LISTON and
