On arrival at the airport ALEX changed the amount of 68.50 DM into Swiss francs. ALEX and FUEGER left Switzerland on schedule. No contacts to third persons were noticed during their last stay in Zurich.

Zurich Police informed that ALEX, who is known to be a gangster boss in the United States and a member of the Chicago crime syndicate, has to be considered as an undesirable person. Therefore, the competent Swiss authorities dealing with foreigners are now entering into the case of ALEX with regard to an interdiction of entry into Switzerland, as further entries of ALEX into Switzerland are anticipated.

The Bureau is requested to confirm arrival of ALEX in the U.S. and inform appropriate Legats.
