The Police Judiciaire (Criminal Police), Surete Nationale (PJSN), advised on February 4, 1964 that subject and girl friend arrived Paris from London January 29, 1964. They stayed at Hotel Bristol, Paris, from January 29, 1964 to February 1, 1964 when they departed hotel for unknown destination. Acted as tourists during stay and were not known to have contacted anyone or to have engaged in any unusual activity.

On February 6, 1964 inquiry at TWA, Paris, revealed subject departed Paris, noon, February 1, 1964, aboard TWA flight 803 en route New York and had further reservations aboard TWA flight 143 to Chicago. No record of DIETGARD FUEGER at TWA for February 1, 1964.

For information of Bureau, TWA, Paris, advised subject in possession of TWA "Ambassador" card reportedly issued to good TWA customers and entitling him to "VIP" treatment.
