It is noted that by letter dated 9/29/52, the Legat, Mexico City mentioned that Mexico City has not set a lead by LHM for the State Department Security Office to check travel by subject GIANCANA because Mexico City does not have current passport data concerning subject GIANCANA, even though it is felt he would be traveling under his true name.
