Reference Mexico City letter 3/26/73.

(S) MEX 34 advised 4/9/73 and 5/1/73 of results of further efforts to locate CELSO CARRETO. He made inquiry at Privada Las Palmas #7, Cuernavaca, Mexico, where CARRETO was working for an American woman but was told that the woman had departed for New York by plane and CARRETO was to follow her in their station wagon taking with him another servant. Supposedly they were to stay in the U. S. some six months. They departed Cuernavaca about the end of 3/73.

At the Post Office in Cuernavaca, he determined that P. O. Box 1066 is still in the name of SCALZETTI but they have not received any correspondence in that box and it does not appear that the box is currently in use.
