On 3/14/74, Captain Antoine Saade, Chief, Technical Bureau, Internal Security Forces (ISF), Beirut, Lebanon (protect identity and organization), advised that the subscribers to telephone numbers in referenced Rome airtel are as follows:

Telephone number 931401 is the Hospital Notre Dame du Liban (Our Lady of Lebanon Hospital), Jounieh, Lebanon.

Telephone number 931407 is Rachid Mourad, Jounieh, Lebanon.

It should be noted that Jounieh is a suburb of Beirut and where the Casino du Liban (Casino of Lebanon) is located.

Under Lebanese law, a subscriber to a phone number can only be obtained by permission of the Attorney General of Lebanon. It was not done in this case; therefore, source and his organization must be protected.

On 3/12/74, the Surete Generale (SG), Beirut, Lebanon, advised that the IBM computer, which houses Arrival and Departure records for individuals entering and exiting Lebanon, has not been repaired. It is expected to be repaired by the end of March, 1974. As soon as it is repaired, Legat will check to determine if CAROLYN MORRIS has visited Lebanon and recheck concerning the subject.
