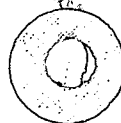
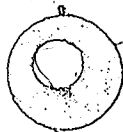

SAMUEL M. GIANCANA, AKA., AR. DAILY SUMMARY.

CG 6498-PC ADVISED THAT DURING LAST MEETING WITH GIANCANA, GIANCANA INFORMED PC THAT HE, GIANCANA, IS SUPPORTING THE CANDIDACY OF BENJAMIN ADAMOWSKI WHO IS RUNNING FOR NOMINATION OF COOK COUNTY STATES ATTORNEY AGAINST JOHN BICKLEY ON THE REPUBLICAN TICKET. NOTED THAT ADAMOWSKI IS FORMER STATES ATTORNEY WHO IS KNOWN TO HAVE HAD ASSOCIATION WITH MEMBERS OF ORGANIZED CRIME HERE IN PAST ALTHOUGH THEY DO NOT ACTUALLY CONTROL HIM. BICKLEY IS FORMER AUSA BEING SUPPORTED BY SHERIFF RICHARD OGILVIE. PC ADVISED THAT GIANCANA GAVE HIM TO UNDERSTAND THAT 19 LOCAL REPUBLICAN WARD COMMITTEEMEN HAVE BEEN LINED UP TO SUPPORT ADAMOWSKI. ✓

PC ALSO ADVISED THAT FROM GIANCANA'S CONVERSATION IT IS APPARENT TO HIM THAT GIANCANA HAS CONTACTS WITH RICHARD GAIN, CHIEF INVESTIGATOR, COOK COUNTY SHERIFF'S OFFICE, PRESENTLY ON TEMPORARY MEDICAL LEAVE. PC UNABLE TO FURNISH FURTHER INFORMATION THIS REGARD. ✓
