The Chicago Division has thoroughly reviewed all the facts and circumstances surrounding the GIANCANA situation as furnished the Bureau in Chicago airtel dated 4/27/64. These additional facts and observations are set forth for the additional consideration of the Bureau in this matter. ✓

The Chicago Office was telephonically contacted at approximately 8:00 p.m., Saturday, 4/25/64, by CG 6293-C and requested that SAs THOMAS W. PARRISH, MARSHALL E. RUTLAND or VINCENT L. INSERRA contact him immediately concerning presence of GIANCANA at the Drake Hotel. It is pointed out that informant is assigned to SA PARRISH, who is presently assigned to Chicago Heights RA and SA RUTLAND is alternate contacting agent as well as SA INSERRA. The informant's original information included facts indicating that GIANCANA would only be expected to be at the hotel for a matter of approximately one hour and one-half. In this original contact the office was advised that also with GIANCANA were four unknown persons, two males and two females. ✓
