Re Chicago teletypes to Bureau and Miami dated June 17 and June 19, 1964.

The following investigation was conducted by SA RICHARD B. KELLOGG:

On June 17, 1964, former PCI MATCHIE ZMISTOWSKI, Lake Worth, Fla., who has met SAMUEL M. GIANCANA in the past (protect at request) advised that around the weekend of June 6-7, 1964, he observed on the course at the Palm Beach National Golf Club, rural Lake Worth, Fla., GIANCANA, PHYLLIS MC GUIRE and JAMES FIORE, the caretaker at the residence of LESLIE E. KRUSE, 1902 Notre Dame Boulevard, Lake Worth. PCI said that is the first time he has observed GIANCANA in that area for possibly five years. He said FIORE acknowledged his presence on the course and spoke to him, but GIANCANA did not. He observed no one else in their company and did not know if GIANCANA was staying at the KRUSE residence in Lake Worth.

On June 18, 1964, MARY E. ROWELL, pro shop, Palm Beach National Golf Club, advised that on June 4, 1964, a Mr. and Mrs. E. PAYNE registered to play and did play golf there. They were accompanied by another man who went on the course with them, but did not play. They got caught in the rain on the course and on returning to the club house Mrs. PAYNE, who had been wearing all
