ST. LOUIS DIVISION ADVISED INTELLIGENCE UNIT, ST. LOUIS PD, RECEIVED INFO ESPOSITO USING ONE HUNDRED DOLLAR A DAY PRESIDENTIAL SUITE, CHASE HOTEL, ST. LOUIS, WHICH SUITE BILLED TO STEPHEN P. GORMAN BRICK CO. DUE TO EXPENSES INCURRED AND SUSPICIOUS CIRCUMSTANCES, ST. LOUIS PD ATTEMPTED TO INTERVIEW ESPOSITO IN HOTEL SUITE AND FOUND HIM TO BE IN COMPANY OF NICOSIA, MARCY AND TISCI. GROUP CALLED IN FOR QUESTIONING AND NO ARRESTS MADE. DURING INTERVIEW ALL CLAIMED TO HAVE ATTENDED STATE FAIR, SPRINGFIELD, PREVIOUS NIGHT AND TRAVELLED TO ST. LOUIS FOR DINNER.

CG SIX FOUR NINE EIGHT - C- TE ADVISED TODAY THAT PURPOSE OF TRAVEL OF ABOVE GROUP WAS TO ATTEND GOVERNOR'S DAY AT STATE FAIR IN SPRINGFIELD. AS IS ANNUAL CUSTOM GROUP THEN TRAVELLED TO ST. LOUIS TO CABARET INASMUCH AS MORE PLEASURES AVAILABLE ST. LOUIS THAN SPRINGFIELD. INFORMANT CERTAIN TRAVEL WAS FOR PLEASURE ONLY.
