GIANCANA, AKA, AR. DAILY SUMMARY.

BROTHER-IN-LAW OF PHYLLIS MC QUIRE, TELEPHONICALLY ADVISED CHICAGO DIVISION THAT IN TRIP TO LAS VEGAS LAST WEEK HE MET WITH JOE PIGNATELLO, FORMER CLOSE ASSOCIATE OF GIANCANA'S WHO TOLD PHYLLIS MC GUIRE HAD INDICATED TO HIM SHE WAS LEAVING LAS VEGAS WEEKEND OF SEPTEMBER 17 LAST FOR CHICAGO "TO SEE TONY ABOUT. UNABLE TO OBTAIN MORE SPECIFIC DETAILS BUT STATED HE ASSUMED SHE WAS CONTACTING "SAM'S SON-IN-LAW" WHO WOULD BE TONY TISCI. TISCI IS ONE OF SEVERAL PERSONS WHO HAVE VISITED GIANCANA SINCE INCARCERATION AND KNOWN TO BE WELL ACQUAINTED WITH MC GUIRE. ALTHOUGH NOT DEEMED. LIKELY, MEETING WOULD HAVE BEEN WITH ANTHONY CHAMPAGNE,. GIANCANA'S ATTORNEY WHO HAS BEEN MEETING HIM FREQUENTLY AT JAIL. NO INFORMATION AVAILABLE FROM CHICAGO INFORMANTS NOTING MC GUIRES PRESENCE THIS CITY. N
