She is, of course, a very reliable and responsible person and a life-long resident of Mexico. She was contacted on this matter because it was known that her daughter attends the Marymount School, which is located in the Rancho Tetela Section of Cuernavaca, Morelos, Mexico. In addition, Mrs. BANNISTER's mother resided in Cuernavaca for many years and worked as a realtor in that area and is widely familiar with persons and property in the Cuernavaca area On September 20, 1967, she confidentially advised that her mother had virtually confirmed that subject was residing at Nubes 2, Cuernavaca. In fact, her mother was in that home about three weeks ago. Her mother is a good friend of Mrs. RUTH DORNBERG, a realtor in Cuernavaca, believed to be German nationality. Mrs. DORNBERG, who was considered responsible and honest, is the administrator for the house at Nubes 2. That is, she handles the hiring and. paying of servants, utilities, etc., for the owner. was showing the house because the owner hoped to rent it during the 1968 Olympics for four thousand dollars. addition, she indicated that he might be selling the house. DORNBERG characterized the owner as immensely wealthy and probably a gangster. DORNBERG mentioned that the owner came and went from Cuernavaca at odd times and at odd hours. She said that the owner had a bank account at the Banco Nacional, Cuernavaca. She noted that the owner received numerous telephone calls

She described the house as luxuriously furnished as if done by an interior decorator to whom expense was no object.

She was most anxious that Mrs. DORNBERG not be advised as to the source of the information that she has knowledge of the occupant of Nubes

On September 20, 1967, Attorney JORGE VAZQUEZ ROBLES, Mexican Immigration, advised that they were confident that it was subject who was residing at Nubes 2 in Cuernavaca, and arrangements have been made so that if he returns he will be detained and deported.
