On February 19, 1968, the Central Bureau, Criminal Division, Italian National Police, Rome, Italy, advised that Italian police had interviewed the two crew members of the yacht "Hamal," and they confirmed the statement made by the owner, GIANFRANCO DONA. Neither knew nor ever heard of SAM GIANCANA, nor was he a guest on the yacht.
