On 5/1,2,3,4/62, efforts were made by Bureau Agent to contact CHAPMAN at his residence and interview him concerning gambling activities in Dallas in general and any knowledge he may have concerning the alleged fixing of SWC basketball officials (DL 165-29). CHAPMAN was not at his residence at any of the times inquiry was made and his wife stated she would have him contact the Dallas Office as soon as he returned to town. On 5/4/62, DL-95-C advised that CHAPMAN was "ducking" his interview with the FBI but informant was unable to furnish reason for CHAPMAN's actions. There was observed a 1962 green Cadillac convertible parked in CHAPMAN's drive way bearing Texas JB 722.

Previous investigation had ascertained that numerous phone calls had been placed from the apartment of MEADOWS' associate BILLY RAY GRIMES to a Fort Worth phone listed to BILL STEWART, 3922 Mercury Street, Fort Worth. On 5/4/62 STEWART, who stated his first name was BENNIE was interviewed by SAs ROBERT M. BARRETT and JOSEPH M. MYERS in Fort Worth. STEWART admitted acquaintance with GRIMES, having known him for about 12 years and identified photographs of JANICE CHRISTAKIS and ALBERT MEADOWS as persons he had seen "some place". STEWART explained the numerous telephone calls between himself and GRIMES as calls wherein he was discussing two Shetland ponies he had left at GRIMES' residence in Dallas. He denied knowledge that GRIMES had operated out of an apartment in Arlington, Texas or any knowledge concerning any bookmaking activities by GRIMES. He stated that although he knew GRIMES almost as well as a son, he didn't know his occupation. He did admit that he has been arrested several times for gambling in Fort Worth and Dallas. Concerning the numerous phone calls in late December 1961, STEWART stated they may have talked about bets but he didn't recall.
