On 5/9/62, DL 95 C furnished the license number of Dallas gambler BOBBY JOE CHAPMAN (DL 162-107) as being Texas PD 1234 on a 1962 white Cadillac. It is noted that the PD series in three digits and the first part of the four digit series (which would include this number) are reserved for Dallas police officers and law enforcement officers living in Dallas County. Reference is made to Dallas airtel, 4/16/62, concerning a possible connection between CHAPMAN and Dallas Vice Squad Detective BILL GEE.

On 5/11/62, the above information was furnished to Lt. JACK REVILL, Intelligence Section, Dallas Police Department, and Deputy Sheriff BOB MORGAN, Dallas Sheriff's Office.

On 5/11/62, Lt. JACK REVILL, Dallas Police Department, furnished the following GIIF information:

He admitted to an extent bookmaking activities in Dallas with some contacts with other persons in Texas, but denied any interstate travel or interstate communications to aid this gambling racket.
