On 7/23/62, DL 91-C advised that BARNEY GIBBS PAYNE had gone to Oklahoma City or Tulsa to arrange for the bonds for subject FUQUA wherein FUQUA could obtain his release from custody in Kansas.

On 7/24/62, DL 95-C advised that PAYNE had been accompanied by EDDIE TOM GREEN (DL 92-360) in their trip to Tulsa, Okla. and all arrangements had been made for FUQUA's release on bond in Kansas. According to CI, GREEN and PAYNE had returned to Dallas, 7/23/62.

By airtel, 7/24/62, Kansas City Office advised that FUQUA, upon interview, had indicated he would assist the Bureau, for remuneration, to locate Bureau Top Ten fugitive, JOHN GIBSON DILLON. FUQUA had been advised to contact the Dallas Office upon his return. By phone call, 7/27/62, Kansas City Office advised that FUQUA had been released from custody 7/26/62 and had returned to Dallas. To date, FUQUA has not contacted the Dallas Office.
