AMATO was connected with CARLOS MARCELLO; however, he did not furnish information which would indicate how he is connected with MARCELLO.

Informant advised that in talking to AMATO, AMATO had stated that he knew that JIMMY JAMES was going to be "hit" three or four months before he had been killed. Informant stated there were two stories curculating concerning the murder of JAMES, one of which was that JAMES was fooling around with a pimp's woman and the pimp killed JAMES; and the second story is that a group from New Orleans wanted a kickback for a return of some \$30,000 to \$40,000 that JAMES reportedly obtained in a card game in Westwego or Grand Isle, La.

Informant advised that JAMES's wife CAROLYN NORRIS JAMES works a pigeon drop scheme with her Negro maid.

On 5/5/70 NO 1283-PC advised SA HAROLD V. HUGHES that he had not learned the name of the trailer park in which ELDON LEGAN is currently residing in the West Bankarea of the Mississippi River adjacent to New Orleans. On 6/4/70 source advised that he believed that LEGAN was living in the Breaux Trailer Park on Barataria Blvd. in Marrero, La.
