DAILY SUMMARY

CG 6576-C* furnished the following further information on 11/13/62 concerning activities within the offices of the First Ward Democratic organization. A lengthy conversation took place between ~~JOSEPH PORCARO~~ Republican Ward Committeeman of the 28th Ward, who, according to CG 6498-PC, is SAM GIANCANA and TONY ACCARDO's man. PORCARO recently was defeated for an elected position in Norwood Heights, a western Chicago suburb, and since his defeat has reactivated himself in Chicago politics. PORCARO's conversation with MARCI is as follows:

PORCARO: This guy OGILVIE wants to be the candidate next time for Governor.

MARCI: I think so.

PORCARO: Oh, positive.

MARCI: I think he's the guy who is gonna screw up ADAMOWSKI. I think this (obs) OGILVIE will fight ADAMOWSKI right down to the wire. He's gonna be a bitch.

PORCARO: He's a cocky (obs), that OGILVIE.

MARCI: OGILVIE is gonna have a tough time with SPENCER though. SPENCER will be out to knock his block off. Yeah, that (obs) will do everything in his power to become Governor.
