SUMMARY

On 6/14/62 [redacted] PH 559-C advised he observed subject, BUFALINO, together with VITO SANTORO and an another unknown man in conversation about 30 minutes in front of SANTORO's Novelty Store on Lackawanna Avenue in Scranton, Pa. The three men went to the back room of the store where they stayed a few minutes and then left.

On 6/15/62 [redacted] PH 521-C advised he heard BUFALINO is going to finance JOE PICCILLO and PETE MORGAN in a bookmaking operation in Pittston, Pa. They tried to lease the store where the "Fern" Poolroom was formerly located, but it had already been leased. They will try to obtain another location. During the past week BUFALINO has been seen several times in the Twin Diner in Pittston, Pa.
