telephone CAnal 6-3142. He spoke to a woman generally in Spanish, but identified himself as Captain TORGAN (PH) rather than as TOM DAVIS. POWELL stated #2 told the woman he would call her at 8:30 A.M. on 4/5/62, and see her on Friday (4/6/62). POWELL stated he believes #2 called this woman MARIA.

On 4/5/62, Mrs. POLLY ANDREWS (protect identity) Southern Bell Telephone and Telegraph Company, Coral Gables, Fla., advised IC E. CLEON GLAZE that telephone CAnal 6-3142 is the unlisted telephone of one PEDRO DIAZ, 120 S. W. 71st Avenue, Miami. DIAZ was identified as having formerly been associated with Bell Helicopter, Ft. Worth, Texas.

Later on 4/5/62, POWELL telephonically contacted SA KELLY and advised that one TARKINGTON left a message at the Green Heron Hotel to have MICKEY call him at room 211, Florida Shores Hotel, Surfside, Fla. POWELL stated he believes TARKINGTON may be identical with #2 individual, TORGAN and DAVIS, mentioned above, since MICKEY, being unable to locate TARKINGTON at the Florida Shores Hotel, asked to speak with the "Texan" who apparently was also staying at the Florida Shores Hotel on 4/5/62.

Q. HUNSAKER (protect), CIA, Miami, advised 4/9/62, that that agency has no operational interest in, or any information concerning, MICKEY, TOM DAVIS, Captain TORGAN, TARKINGTON or DIAZ.

It is suggested that Dallas determine the address of MARY LYNN BUSH, Ft. Worth telephone 62887. Dallas should also check credit and criminal and logical sources regarding BUSH, TOM DAVIS, ED HEIGHT and PEDRO DIAZ (not further identified by 2nd family name) formerly associated with Bell Helicopter, Ft. Worth.

An information copy is designated for Houston since MICKEY reportedly planned to meet TOLLIVER in Houston during the weekend of 4/6-8/62.

It is suggested that Minneapolis check indices, credit and criminal records, Bureau of Motor Vehicles and other logical sources regarding R. E. MICKEY.
