DETAILS:I. RESIDENCE

CG T-1 advised that although ALEX was not observed at his residence during a period of approximately six weeks, from early June to Late July, he continues to reside at 1300 Lake Shore Drive, in Apartment 31 B.

II. EUROPEAN TRAVEL OF ALEX

CG T-2 advised that from June 12, until June 15, 1969, ALEX and his wife SUZANNE FUEGER ALEX, were lodged at the Excelsior Hotel in Naples, Italy. CG T-2 advised that ALEX and his wife departed Naples for Rome on June 15, 1969.

CG T-2 advised that during this stay in Italy ALEX was in possession of United States passport number 135685, issued on January 31, 1968, and his wife was in possession of German passport 4019969, issued at Chicago, Illinois, on October 16, 1967.

During the period June 30, 1969, through July 2, 1969, CG T-3 advised that GUS ALEX was then residing with his wife at 12 Marthabraustrasse, Fuerstenfeldbruck, Federal Republic of Germany.

It is noted that it is believed that the Fuerstenfeldbruck address is the home of the mother of Mrs. ALEX.

CG T-4 advised that in late July, or possibly very early August, ALEX returned to Chicago from his lengthy European travel.

III. CURRENT ACTIVITIES OF GUS ALEX

CG ~~T-3~~<sup>T-4</sup> advised that upon the return of ALEX to the United States, he reinstated his practice of meeting with his associates in the leadership of organized crime, RALPH PIERCE and LESLIE KRUSE. However, according to this source, these meetings have diminished in volume substantially and ALEX is currently
