## DETAILS:

As has previously been reported ALEX left the United States on June 13, 1970, and it was determined that he visited several European countries including Germany and Italy.

The Italian National Police in Rome advised on September 17, 1970, that ALEX and his wife arrived there at the Frumicino Airport on August 27, 1970, aboard Lufthansa Flight 342. While they remained in Rome they took up lodging at the Hotel Hassler. Although the Italian National Police attempted to determined when ALEX left Rome and Italy they were unable to do so.
