RE CHICAGO TEL TO BUREAU, FEBRUARY FOURTEEN LAST.

THE ATTENTION OF THE BUREAU AND CHICAGO IS CALLED TO LAS VEGAS AIRTEL TO BUREAU, JANUARY NINETEEN LAST, CAPTIONED, LESLIE EARL KRUSE, AKA., AR, 00: CHICAGO, BUREAU FILE NINE TWO DASH FIVE FIVE ZERO FIVE, WHEREIN ON JANUARY THIRTEEN LAST, LV ONE SEVEN SEVEN DASH C ADVISED THAT SIDNEY KORSHAK ARRIVED AT THE RIVIERA HOTEL, LAS VEGAS ON JANUARY TWELVE LAST WITH ACTRESS JILL ST. JOHN. SOURCE NOTED THAT KORSHAK HAS BEEN IN POOR HEALTH AND HAS NOT BEEN AT THE RIVIERA HOTEL IN OVER SIX MONTHS. SOURCE DID NOT KNOW PURPOSE OF VISIT. SOURCE NOTED THAT EDWARD TORRES, MAJOR OWNER RIVIERA HOTEL IS REPORTEDLY BUYING THE TEN PER CENT OWNERSHIP OF DEAN MARTIN, WELL KNOWN ENTERTAINER, SINCE TORRES BECAME DISSATISFIED WITH MARTIN.

THIS IS THE ONLY CURRENT DEVELOPMENT KNOWN TO THE LAS VEGAS DIVISION WHICH WOULD BE OF INTEREST TO KORSHAK AND OR OTHER CHICAGO HOODLUMS.
