The Bundeskriminalamt (BKA - West German Federal Criminal Police) has furnished the following information which originated with the Police of Fuerstenfeldbruck, Federal Republic of Germany (FRG).

No information has been developed that the subject or his wife has visited in Fuerstenfeldbruck since the summer Inquiries have indicated that the subject's motherin-law, Mrs. FUEGER, does not expect a visit from the subject and his wife. This is primarily true because the motherin-law only returned from the United States about three weeks ago having spent the major part of the past winter with her daughter. Inquiries in the vicinity of the address #12 Marthabraeustrasse, Fuerstenfeldbruck, developed that the caretaker of the apartments at that address has not seen the subject recently.
