leaving Los Angeles in a couple of days to visit San Francisco and that, although he knew San Francisco LCN boss JIMMY LANZA, TRAFFICANTE did not indicate was going there to conduct LCN business. TRAFFICANTE furnished the informant with his Miami and Tampa residence addresses and telephone numbers and suggested that it would be safer for the informant to contact him through his North Miami, Florida address.

Subsequently, on 4/12/68, informant advised that on 4/11/68 TRAFFICANTE and his wife had arrived at the San Diego Airport and after lunch TRAFFICANTE and his wife had taken a taxi to Tijuana and claimed intended to proceed from Tijuana Mexican Airlines to Mexico City and that they planned to be home by Easter.

If Los Angeles has a reliable source and can contact this source at the Beverly Hillcrest, will determine time TRAFFICANTE checked into hotel, identity of any local or long distance calls, departure, and how bill paid.

2. Will after above, contact air lines serving Los Angeles - San Francisco in an attempt to obtain details of TRAFFICANTE's travel from Los Angeles to San Francisco.
