For the information of the Bureau and Tampa, on May 29, 1968, MM 1231-C-TE advised the following regarding those persons whom he knows to be LCN members:

DOMINICK DEA, known to the informant as "Little Dom," from Tampa, now residing in Miami, is a member of the TRAFFICANTE family and handles numbers, bookmaking and strip parlors if and when this is possible. LEA formerly had strip houses in Tampa and in Broward County, Florida, and until recently had a card room on Sunny Isles, next to or across the street from the psychedelic parlor on Sunny Isles Boulevard.

In addition to LEA, the only other TRAFFICANTE family members known to be the informant to be residing in Miami are WILLIE DENTAMORA and TONY RANDAZZO. Informant states that RANDAZZO is the one person in whom TRAFFICANTE has complete confidence, and who is always aware of the whereabouts and activities of TRAFFICANTE.

Informant stated that VINCENT BRUNO, owner of Capra's Restaurant, although a close confidant of TRAFFICANTE who meets regularly at his restaurant, is not considered an LCN member, but at best would be classed as an "Amici."
