ADMINISTRATIVE

This case has been maintained in a pending status in the Miami Office by communications to the Bureau and interoffice communications. All pertinent information regarding the activities of the subject have been disseminated in this matter.

An information copy of this report is being provided for the Los Angeles Division in view of their interest in JOSEPH JOHN ROMANO, JR., and his association with SANTO TRAFFICANTE, JR.

INFORMANTS

On August 8, 1973, Italian National Police (INP) advised Legat Rome that it had received a telegram from Interpol, Washington, D.C. on August 8, 1973, alerting police as to the travel of SANTO TRAFFICANTE, JR., to Italy. The INP advised Interpol on August 14, 1973, that two inquiries revealed that the subject and his wife JOSEPHINE stayed at Hotel De La Ville, Florence, Italy, on June 4, 1973, leaving that city June 5, 1973, for an unknown destination. No other pertinent information was developed by the INP.

Information was received from the Interpol Unit of New Scotland Yard (NSY) on August 10, 1973, that they had received a cable from Interpol, Washington, advising in substance that captioned subject was traveling in Europe. Interpol was instructed to place appropriate stops regarding the subject; however, if found he was not to be questioned by police, per Interpol, Washington advised.

On August 22, 1973, SA WILLIAM WHITNEY, Florida
Department of Law Enforcement (FDLE) advised that his department
had confirmed information that SANTO TRAFFICANTE was residing
in Spain. According to WHITNEY's information, TRAFFICANTE did
not plan to return to the United States and quit the rackets.
In addition WHITNEY mentioned that his information reflected
that TRAFFICANTE plans to move his entire family to Spain
with him.

On October 17, 1973, TP 287-C advised he was in contact with a relative of SANTO TRAFFICANTE and ascertained that TRAFFICANTE is now residing in Catania, Italy, which is on the island of Sicily. According to the source, TRAFFICANTE has been residing there for approximately six months.

On September 12 and 25, 1973, TP 41-C-TE advised that it is his understanding that SANTO TRAFFICANTE, JR., is definitely out of the United States and is believed somewhere in Europe. Source advised that close associates of TRAFFICANTE indicated that he has decided to go to Europe in an effort to get away from any type of police investigation in the states. Source indicated that he would attempt to find out if and when he plans to return to the States.

On September 14, 1973, TP 1960-PC advised that SANTO TRAFFICANTE is still out of town and probably believed in Europe. Source advised he recently saw AUGUST PANIELIO, son-in-law of TRAFFICANTE, a few days ago and found out that TRAFFICANTE's daughters have recently returned from their beach house in St. Petersburg, Florida, and are now back in Tampa.

On September 28, 1973, TP 41-C-TE advised that he had recently been in contact with SANTO TRAFFICANTE's son-in-law AUGUST PANIELLO at the United Cab Company and was advised that SANTO TRAFFICANTE, JR., was in Miami approximately two or three weeks ago for one day as he had come from Europe to transact some business. Source advised that after conducting his business, TRAFFICANTE almost immediately left the Miami area. Source advised that it was his understanding that TRAFFICANTE returned to Europe.

On October 12, 1973, TP 2025-PC advised that he had operated a gambling casino in Cuba for the TRAFFICANTE organization many years ago. He stated he was approached and offered the job because the casino was losing money and the organization was interested in getting it back on a paying basis. The source stated he traveled to Cuba and shortly after his arrival, he got things straightened out and eventually the casino was making a profit of \$20,000 or better a month. He stated that all took place in the 1950's.

TP 2025-PC advised that they would get the money back into the states by carrying it through Customs on their person. He stated that a good portion of the time they would simply contact a diplomat and pay him to carry it through Customs in his diplomatic pouch. Source advised that it was not difficult to get a diplomat to do this as they always made it worthwhile for them.

On October 12, 1973, TP 41-C-TE advised that he had received additional information regarding the activities of SANTO TRAFFICANTE, JR., and that after leaving the Miami area in mid September, he traveled to South America, but his definite destination was unknown. Source stated that it was his understanding that TRAFFICANTE may be negotiating with individuals concerning setting up an operation of casino type, gambling, in South America. Source stated that TRAFFICANTE's wife is presently in the Tampa area staying with her daughter who is married to AUGUST PANIELLO.

TP 41-C-TE advised that it was his understanding that TRAFFICANTE is going to return to the Florida area in the latter part of October.

The Central Bureau, Criminal Division, Italian
National Police (INP), Rome Italy, advised Legat Rome on
October 24, 1973, that no additional information has been
received from alert police districts in Italy regarding the
travel of TRAFFICANTE in any other Italian city. INP advised
that subject is included on it's watch list and should any
pertinent information be received in the future, Legat Rome
will be informed.

On November 28, 1973, TP 41-C-TE advised that information received from SANTO TRAFFICANTE's close associate JIMMY LONGO revealed that TRAFFICANTE was in the Miami area. Source stated that TRAFFICANTE's wife was in Miami with him and that the TRAFFICANTES did not plan to go to the Tampa, Florida, area for the Christmas holidays as has been their usual practice. Source stated that he was not aware of the

means of traveling TRAFFICANTE used when he re-entered the United States. Source further advised that he was going to attempt to obtain two days off from his employment during the following week and was planning to travel to the Miami area to meet with TRAFFICANTE.

On December 4, 1973, MM 1401-C-TE who was conversant with movements with many prior ranking La Cosa Nostra (LCN) figures in the Miami area and elsewhere, including SANTO TRAFFICANTE, advised that he was most confident that TRAFFICANTE was not in the Miami area and has not been in the vicinity for quite some time. It was source's opinion that if TRAFFICANTE were in the State of Florida, he would be in the Tampa area at Christmas time rather than in the Miami area since his at Christmas time rather than in the Miami area since his relatives are there and since he is too well known to all law enforcement officers and agencies in the Miami area.

On December 13, 1973, TP 41-C-TE advised that TRAFFICANTE was located in Costa Rica and that he planned to return to the United States within a ten day period in order to spend the holidays with relatives. Source stated that previous information supplied by JIMMY LONGO proved to be faulty and false and source still intended to meet with TRAFFICANTE upon his arrival in the United States.

On December 12, 1973, NK 2591-C-TE advised that SANTO TRAFFICANTE had recently been contacted by "FRANK The Wop" (true name FRANK SABASTIAN GAGLIARDI). "FRANK The Wop", a member of the GAMBINO family, is presently involved in the construction of condominiums in the Miami area and approached construction of condominiums in the Miami area and approached trafficante with a proposal for general construction in the Tampa area.

According to the source, the financing behind these condominiums is coming from New York and Miami"racket guys" such as ANTHONY ACCETURO.

Source further stated that TRAFFICANTE allegedly turned thumbs down on the deal saying that he did not want such investments in Tampa because there was already too much "heat" without additional crime figures in the area.
