UNSUBS; LOCAL 901, TEAMSTERS UNION, SJ, PR; LMRDA - IM.

RESJRAD TO BUREAU MARCH 7 LAST.

LT. RAFAEL ALVAREZ (NA), POPR, TODAY ADVISED SJO THAT POPR INFORMANT "ACE", PREVIOUSLY IDENTIFIED, TOLD ALVAREZ APRIL 9 LAST THAT REASON THE BOOKS AND RECORDS OF TEAMSTER LOCAL 901 NEVER ARRIVED BY MAIL IN THE STATES WAS DUE TO THE FACT THAT THEY WERE BURNED BY LUIS E. PAGAN, BOOKKEEPER, LOCAL 901, AND LEOPOLDO RAMOS DUCOS, TEAMSTERS ORGANIZER. ACE LEARNED THIS IN CONVERSATION WITH PAGAN, AND WHEN ACE TOLD PAGAN THAT PAGAN HAD BEEN PHOTOGRAPHED IN ACT OF BURNING RECORDS, PAGAN STATED THIS WAS IMPOSSIBLE, AS PICTURES CANNOT BE TAKEN AT NIGHT. INFORMANT UNABLE TO SUPPLY ADDITIONAL DETAILS AS TO PLACE OR EXACT DATE RECORDS BURNED, BUT LT. ALVAREZ HAVING INFORMANT DETERMINE THIS AS SOON AS POSSIBLE, IN ADDITION TO IDENTITIES OF ANY OTHER INDIVIDUALS PAGAN MIGHT HAVE TOLD RE BURNING OF RECORDS. INFORMANT STATED RECORDS WERE BURNED AT INSTRUCTION OF FRANK CHAVEZ, AND APPARENTLY AFTER FGJ SUBPOENA ISSUED FOR SAME. FACTS DISCUSSED WITH USA FRANCISCO A. GIL, SJ TODAY, WHO ADVISED HE IS AWAITING INSTRUCTIONS FROM DEPARTMENT AS TO PROCEDURE IN FILING ORDER TO SHOW CAUSE FOR CONTEMPT ACTION AGAINST CHAVEZ. BUREAU WILL BE KEPT ADVISED OF ANY PERTINENT DEVELOPMENTS.
