AL WAINER, FORMER CHICAGO ~~QUOTE~~ FENCE ~~UNQUOTE~~ AND AN OLD TIME ASSOCIATE OF NUMEROUS TOP CHICAGO HOODLUMS ADVISED ON SEVEN TWENTY TWO LAST THAT HE WAS OF THE OPINION THAT SAMUEL GIANCANA IS LIKELY TO BE IN TROUBLE WITH MEMBERS OF THE ORGANIZED CRIMINAL GROUP IN CHICAGO BECAUSE OF RECENT PUBLICITY FOCUSED UPON GIANCANA-S ACTIVITIES.
