Sergeant Patrick Haraty, Research Unit, Intelligence Unit, Chicago Police Department, advised the Chicago Office 2/2/67 he received a letter that date from one S. E. Hurst, Department of Manpower in Immigration, Field Investigations Division, Canadian Government, asking for background information regarding Giancana and associates who may accompany him to Canada in case he should travel there when McGuire Sisters appear at Elmwood Casino, Windsor, Ontario, March, 1967. Letter stated Canadian Government intends to obtain warrant for arrest of Giancana for violation of their Immigration Act should he appear in Canada at this time or presumably any other time. (U)

Sergeant Haraty was furnished general background regarding Giancana and it was suggested to him that Dominic "Butch" Blasi and/or Anthony P. Tisci would be most likely associates who might accompany Giancana. (U)

Sergeant Haraty advised he saw no reason why any contact of RCMP by FBI and reference to letter of Hurst would compromise him. Legat requested to ascertain through appropriate contacts whether Canadian Government has any specific information that Giancana will travel to Canada and advise Bureau of details. (U)
