ROSSETTI is paying \$200 a week for this service which money is transmitted via Western Union Money Order addressed to PAUL KING from Mrs. PAUL KING in Boston, Mass.

Since the racing season has begun, the results of each race has been secured through the cooperation of a local book maker who receives the results from a local wire service, and then the information is relayed by either PAUL KING or JERRY BROWN to Boston. Daily at post time, ROSSETTI or an individual who works for ROSSETTI named BILL, will call the number in New Orleans, where KING or BROWN is located and receive the racing results.

NO 1230C advised he believes that they are using a pay telephone in Boston to make calls, however, they may not be using the pay phone for every call.

The above information has been submitted to Boston via separated communication.

Close contact is being maintained with NO 1230C to obtain the details of the daily activities of ROSSETTI in Boston, Mass.
