CRIME CONDITIONS, JEFFERSON PARISH

The Democratic primary run-off election of 1/11/64 at Jefferson Parish, Louisiana, resulted in the election of ALWYNN J. CRONVICH and most of the candidates of the THOMPSON P. DONELON - ALWYNN J. CRONVICH ticket.

From numerous sources, including various public statements, information has been received that after the new sheriff takes office on 5/22/64, there will be a general clean-up of gambling in Jefferson Parish, and information was received from NO 1243-PC that there is talk among the gambling circles that CARLOS MARCELLO, New Orleans top hoodlum, was contemplating moving his gambling interests to St. Tammany Parish, Louisiana. There has been no confirmation of this rumor to date.
