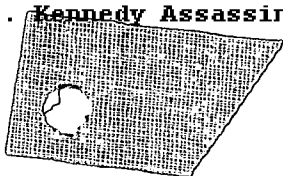

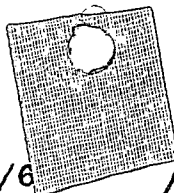

WEEKLY SUMMARY

Subject has not been reported by sources at Tampa.

KENNETH LEON GUTHRIE, Installer, General Telephone Co. of Florida, interviewed, and claimed he had been a friend of JAMES C. LONGO for approximately five years, and has done some extra-job electrical work for LONGO and his friends. He stated a friend of LONGO's was SANTO TRAFFICANTE, who had electrical motors on double garage doors at 2505 Bristol, Tampa, which are operated from switches in various automobiles, and that such were inoperative, and LONGO called him over to subject's residence shortly after New Year's, 1963 (known from FISUR 2505 Bristol Ave., that it was night of 1/2/63) at which time he saw Mr. and Mrs. SANTO TRAFFICANTE, JAMES LONGO, and a man introduced as LOU - LNU. (Known to be LOUIS P. BRADY, subject of AR case, OO Chicago). GUTHRIE stated he agreed with Mrs. TRAFFICANTE that he would install a new motor for the garage doors.

He claimed he also did electrical work through LONGO's assistance at residences of GINES ("California") RIVERO, JOHN DEMMI, (alleged Tampa gambling figures) and at the home of FRANK RAGANO, Tampa attorney for the TRAFFICANTES.

GUTHRIE claims he never did any telephone company work for such individuals, and emphatically denied he ever furnished any information from telephone records to unauthorized
