WEEKLY SUMMARY

The Houston Office advised PHILLIP GRANDIO, JR. interviewed at Texas City, Tex., and he advised subject was unknown to him and although he formerly lived in Tampa he could furnish no information concerning numbers racket and subject's associates were unknown to him.

New Orleans Office reported results of interview of WILLIE PEP, former featherweight boxing champion of the world, who admitted he knew the subject and JAMES LONGO in the past but he had no business relations with TRAFFICANTE. PEP denied ever having asked anyone to intercede on his behalf to collect owed him, denied knowing anyone by the name of "SPRINGFIELD SAM" and denied requesting assistance from anyone relative to the collection of any money, and nothing of significance was ascertained from PEP.

On 3/26/63, Sgt. JACK DE LA LLANA, Intelligence Unit, Tampa PD, advised he had received no information that subject was in Tampa but noted that on the evening of 3/25/63 he had followed JAMES C. LONGO from the area of the Columbia Restaurant to 2505 Bristol Avenue where he entered at approximately 5:30 p.m. alone. He said, however, subject was not seen.

On 3/27/63, the Miami Office was advised by SA LIONEL E. BELANGER that TP 31-C was en route to Miami, Fla., and was anticipated contacting subject there.

As of 3/29/63, sources have not reported subject as being in Tampa, and he has not been observed through daily spot checks of his residence.
