Early morning of 7/29/64, TP 120-C advised subject arrived 2505 Bristol Avenue, Tampa, Florida, in taxicab about 3:00 P.M. Sunday, July 26, having flown into Tampa. Source advised subject remarked JAMES C. LONGO was doing fine, and his wife, ROSE LONGO, still has not been told of his condition. Source said subject was at his residence for two or three hours, and was taken to the airport Sunday night to go to Miami.

On Monday morning, July 22, 1964, subject's wife, daughter MARY JO PANIELLO, daughter and son-in-law, SARAH ANN and RICHARD VALDEZ all left Monday morning for Miami for at least one week stay. Source said AUGIE PANIELLO remains in Tampa.
