Chicago informant 6283 - C was recently contacted by an associate of Pat Marcy, Hoodlum representative in Chicago, First Ward, concerning outstanding underworld offer of \$100,000 for legal way to free Giancana from incarceration of contempt charges. Informant^{was} advised that if he could succeed in arranging this he would be virtually assured of local judgeship. Attorneys for Giancana have filed another emergency motion for stay of incarceration pending decision on appeal on merits of contempt action against Giancana. Government given until July 19, 1965, to answer motion.

ATTORNEY TOM WADDEN FILED ANOTHER EMERGENCY MOTION FOR STAY PENDING APPEAL ON BEHALF OF GIANCANA BEFORE SEVENTH CIRCUIT COURT OF APPEALS ON JULY 15 LAST. APPELLANT RENEWED HIS PRIOR MOTIONS FOR STAY ON GROUND THAT BRIEF, NOW FILED WITH COURT RE THIS ACTION, DEMONSTRATES STROND LIKELIHOOD THAT HE WILL PREVAIL ON THE MERITS AND THEREFORE, JUSTIFIES THE INTERMITTANT RELIEF. U

BRIEF STATES THAT THREE FACTORS JUSTIFY PRESENT REQUEST FOR STAY PENDING APPEAL, ONE, STAY WILL MAINTAIN THE STATUS QUO: TWO, THERE IS SUBSTANTIAL LIKLIHOOD THAT APPELLANT WILL PREVAIL ON APPEAL: THREE, WITHOUT SUCH RELIEF, APPELLANT WILL SUFFER IRREPARABLE INJURY. U
