GUS ALEX, AKA, AR. DAILY SUMMARY. CG SIX FOUR FOUR THREE DASH C ADVISED THAT THE HARVEY WRECKING COMPANY PRESENTLY OWNED BY FRED AND HARVEY GOLDBERG IS QUOTE OUTFIT CONTROLLED ENQUOTE. OUTFIT CONTROL DATES BACK TO THE TIME THE GOLDBERG FAMILY OWNED THE WURLITZER RECORD AND MUSIC BOX COMPANY IN CHICAGO AND IN WHICH THE LATE JAKE GUSIK HAD AN INTEREST. SAID THE GOLDBERG FAMILY ARE NO LONGER OWNERS OF THE WURLITZER COMPANY, HOWEVER, STILL ARE THE OWNERS OF HARVEY WRECKING COMPANY. STATES THAT SINCE GUSIK-S DEATH IN NINETEEN FIFTY SIX GOLDBERG-S INTEREST IN THE HARVEY WRECKING COMPANY IS SPLIT AMONG ALEX, MURRAY HUMPHREYS AND INDIVIDUAL KNOWN AS JOE LOGAN. STATED THAT HARVEY WRECKING COMPANY AND THE SPEEDWAY WRECKING COMPANY OF CHICAGO, WHICH DOES A HUGE AMOUNT OF WRECKING BOTH FOR PRIVATE CONTRACTORS AND FOR THE CITY OF CHICAGO, ARE CONSPIRING ON BIDS TO

WRECK BUILDINGS IN THE CHICAGO AREA. CG SIX FOUR FOUR THREE DASH C HAS PREVIOUSLY ADVISED SPEEDWAY WRECKING COMPANY IS HOODLUM CONTROLLED AND THAT ALEX HAD AN INTEREST IN THIS COMPANY. STATED THESE WRECKING COMPANIES FIND THAT BY SPLITTING THE BUSINESS THEY ARE BETTER ABLE TO PERFORM THEIR CONTRACTS ON A SCHEDULED BASIS AND THAT BY CONTROLLING THE BIDDING MOST OF THE WRECKING BUSINESS IN CHICAGO ARE BID BY THESE TWO COMPANIES. <sup>FLL</sup> JOE LOGAN INTERVIEWED THIS DATE AND ADVISED THAT HIS LEGAL NAME IS JOE BAGNOLA LOGAN, THE NAME LOGAN BEING ADDED TO HIS REAL NAME BAGNOLA WHEN HE WAS A BOXER IN HIS YOUNGER DAYS. LOGAN STATED THAT HE FORMERLY RAN A BOOK AT VAN BUREN AND STATE STREETS, CHICAGO FROM SEPTEMBER NINETEEN THIRTY TWO TO NINETEEN FORTY ONE. STATED THAT DURING THIS TIME HE WAS A CLOSE FRIEND OF MICHAEL KENNA, <sup>FLL</sup> NOW DECEASED WHO WAS ALDERMAN AND COMMTEEMAN OF CHICAGO-S FIRST WARD UNTIL NINETEEN FORTY SIX ~~IN~~ WHEN HE DIED. HE STATED THAT THROUGH HIS FRIENDSHIP WITH KEENA HE WAS ABLE TO OPERATE HIS BOOK WITHOUT ANY INTERFERENCE OR CONTROL FROM THE OUTFIT. LOGAN STATED THAT AFTER <sup>N</sup> KEENA-S DEATH HE BOOTLEGGED A FEW BETS UNTIL ABOUT TWO YEARS AGO
