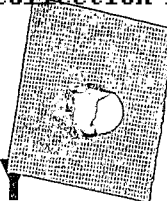
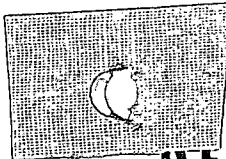

CONCERNING A CHARRED MALE TORSO BURNED BEYOND
RECOGNITION IN STICKNEY, ILLINOIS INCINERATOR DISCOVERED
ABOUT ONE WEEK AGO, CG 6461-C ADVISED LAST NIGHT THIS
PERSON BELIEVED IDENTICAL TO JOHN ROBINSON, A NEGRO
TAVERN OWNER, 3300 BLOCK WEST ROOSEVELT, CHICAGO, WHO
WAS CONNECTED WITH BENJAMIN LEWIS IN A REAL ESTATE
DEAL. ACCORDING TO INFORMANT, ROBINSON REPORTEDLY WAS
IN DEBT ON JUICE LOANS.

INFORMANT, WHO HAS BEEN LONG ACQUAINTED WITH GAMBLING
AND 24TH WARD ACTIVITIES, STATED LEWIS ALSO INDEBTED TO
"JUICE OPERATORS FROM CICERO," WHICH INFORMANT BELIEVES
WAS REASON FOR SLAYING. INFORMANT CLAIMS THAT A SERGEANT
LEROY LEVY, CHICAGO POLICE OFFICER, FILLMORE DISTRICT,
REPORTEDLY HAS INTIMATE KNOWLEDGE CONCERNING ACTIVITIES
OF LEWIS AND POSSIBLY MOTIVE FOR SLAYING. LEVY ALLEGED
TO CONTROL VARIOUS GAMBLING ACTIVITIES FOR CRIMINAL
GROUP AND IS A PROTECTOR OF THIS GROUP INTERESTS IN THE
24TH WARD.

NOTED THAT SERGEANT LEVY REPORTED BY CG 6512-C-TE
HAS STRONG HOODLUM TIES WITH THE SAM AND CHUCK ENGLISH
ORGANIZATION. ABOVE INFORMATION BEING FURNISHED TO
ROSWELL SPENCER, CHIEF INVESTIGATOR, STATES ATTORNEY'S
OFFICE, WHO IS PRESENTLY INVESTIGATING MATTER.
